It is agreed as follows:


1. With effect from 02/12/2020 the Original Grant Agreement shall be amended as set out in this Change Control Note:

Annex B - Revised Specification

Due to the impacts of COVID-19, delays to the delivery of some activities will be experienced as they take place between 2021 and 2023, resulting in a need of an extension until 2024 to complete the full suite of activities. In some cases (particularly in Madagascar), activities have continued, but targets will not be met in the same amount of time due to changing baselines. The extension of the Blue Forests programme aims to allow activities to be completed and targets to be met.
