Background

The Parties have agreed to vary the Grant Agreement to extend the time given to complete Funded Activities of the catalyst projects in Annex 2 until 30 November 2020, as per the terms set out in this Variation Agreement. This is a no-cost extension and was agreed to provide research projects funded using the Authority's funds through the Grant Recipient extended time to complete their projects.
