WHEREAS the Recipient and the Authority entered into a Grant Agreement for the Project dated December 2016 (the "Original Grant Agreement") and now wish to amend the Original Grant Agreement

IT IS AGREED as follows

#### 1. CHANGES

- 1.1 With effect from 20<sup>th</sup> April 2018 the Original Grant Agreement shall be amended as set out in this Change Control Note:

Change requestor/originator: Blue Ventures Conservation

Summary and reason for change:

The proposed delivery plan for the Project which has been approved by the Authority requires the building of simple constructions - basic wooden or stone buildings - where no infrastructure currently exists and without them creates significant issues undertaking planned work and risks not delivering against objectives. The buildings are needed, for example, as workshops for aquaculture materials and pen constructions, technician housing, offices and security structures/guard towers in the coastal waters. At the end of the Grant Period (or sooner if practicable) such buildings shall be handed over to the local community.

In the longer term the Project will require a higher specification building for the development of a sea cucumber hatchery. This is vital for programme development. Plans for such buildings will need to be agreed in future project activity plans accordingly.

Accordingly, the Parties wish to delete the current wording in clause 6.3 aa) of the Original Grant Agreement which currently prohibits the "*purchase of land or the purchase and/or construction of buildings*".

And replace this in its entirety with the following wording:

*"6.3 aa purchase of land or the purchase and/or construction of buildings except where the Authority has given its prior written consent to the*

To obtain consent, the Recipient must confirm in writing:</i></p> <p><i>(i) that such land or buildings are essential to the successful delivery of the Project;</i></p> <p><i>(ii) detail of the proposed purchase and/or construction work in a Project delivery plan;</i></p> <p><i>(iii) that all land purchased and buildings constructed and/or purchased will be handed over to the local community either during or at the end of the Grant Period,</i></p> <p><i>And the Authority may refuse consent where any of these are not provided and/or it reasonably disputes any of the detail provided.”</i></p>
