Sir/Madam,

I have the honour to refer to the status of your Government's contributions towards the Trust Fund for the Multilateral Fund for the Implementation of the Montreal Protocol on Substances that Deplete the Ozone Layer, of the United Nations Environment Programme (UNEP).

The Fourth Extraordinary Meeting of the Parties to the Montreal Protocol on Substances that Deplete the Ozone Layer held online on 21 May 2021, noted that any contributions made by parties in advance of a final decision including a revised budget for the Multilateral Fund for the triennium 2021–2023 and of a decision on the potential extension of the fixed-exchange-rate mechanism would count towards the level of contributions to be decided on for the triennium 2021–2023. Parties adopted the level of indicative contributions for the parties listed in table A for 2021 on an interim basis in advance of a final decision by the Meeting of the Parties on a revised budget for the Multilateral Fund for the triennium 2021–2023. Any contributions by parties made in advance of a final decision on the revised budget for the Multilateral Fund for the triennium 2021–2023 shall be without prejudice to the overall level of the replenishment or to the agreed level of contributions by parties.

I have attached an invoice for your Government's pledge for 2021, and where applicable, outstanding contributions for prior years, as indicated in the records of the Secretariat.

I would be grateful if you could kindly contact the appropriate authorities regarding settlement of the invoiced amount. Please indicate clearly that the payment relates to **40MFL-UK**.
