I have the honour to refer to the status of your Government's contributions towards the Trust Fund for the Multilateral Fund for the Implementation of the Montreal Protocol on Substances that Deplete the Ozone Layer, of the United Nations Environment Programme (UNEP).

The Fifth Extraordinary Meeting of the Parties to the Montreal Protocol on Substances that Deplete the Ozone Layer that was held in Bangkok on 16 July 2022 decided through Decision Ex.V/1 paragraph 4, to adopt the scale of contributions for the Multilateral Fund for the triennium 2021–2023 based on replenishment of \$475 million for the triennium 2021–2023 as it appears in the annex to the report of the Fifth Extraordinary Meeting of the Parties to the Montreal Protocol. Additionally, Decision Ex.V/2 paragraph 6, urges parties to pay their contributions to the Multilateral Fund in full and as early as possible in accordance with paragraph 7 of decision XI/6.
