AMENDMENT NO. 3

to the

ADMINISTRATIVE AGREEMENT REGARDING THE CONTRIBUTION TO THE INTER-AMERICAN DEVELOPMENT BANK FOR THE FUND TITLED "U.K. BLUE CARBON FUND"

WHEREAS, the Department for Environment, Food and Rural Affairs of the Government of the United Kingdom of Great Britain and Northern Ireland ("DEFRA" or "Donor") and the Inter-American Development Bank (the "IDB", and together with "DEFRA", the "Parties") entered into the Agreement regarding the Establishment of the UK Blue Carbon Fund ("Fund") dated March 21st, 2019 (the "Agreement"), as amended.

WHEREAS, the Parties wish to modify the total amount of the Contribution to £12,950,000 (twelve million, nine hundred fifty thousand Pounds Sterling) and, consequently, amend Paragraphs 1.1 and 1.3 of the Agreement, as previously amended.

NOW, THEREFORE, the Parties agree as follows:

- To modify Paragraph 1.1, which shall read as follows: Defra agrees to make a
 contribution of £12,950,000 (twelve million nine hundred fifty thousand Pounds
 Sterling) (the "Contribution" or "Fund Resources"), to be administered by the IDB
 for the single-donor fund titled "U.K. Blue Carbon Fund" (the "Fund"). The
 Contribution will be utilized for the purposes of the Fund and the IDB is not expected
 to return the Contribution, except for the cases listed in Sections 7.3 and 7.5.
- 2. To modify Paragraph 1.3 of this Administrative Agreement, as amended, which shall read as follows: The Donor will deposit the Contribution in eight (8) installments into an account indicated by the IDB in writing, and upon written request by the IDB, in accordance with the following payment schedule:

- 3. This Amendment No. 3 will enter into effect upon signature by the Parties and will constitute an amendment to and form an integral part of the Agreement.
- 4. For the avoidance of doubt, all terms and provisions of the Agreement not expressly modified in this Amendment No. 3 shall remain in full force and effect.
- 5. Capitalized terms used but not defined in this Amendment No. 3 shall have the meanings ascribed to them in the Agreement.
